ENTRY FEE

The entry fee for the EB100 2027 is £149 + VAT per entry. An invoice will be issued following submission of your entry, and payment must be made in accordance with the invoice terms.

UNPAID ENTRIES

Any application submitted without full payment of the entry fee will not be accepted into the EB100 2027 judging process and will not be considered for inclusion in the rankings. Only entries where the entry fee has been received in full will be eligible for assessment.

REDEEMABLE CREDIT

Credit value: The redeemable credit is £149 (excluding VAT). The VAT element of the entry fee is not redeemable as credit.

The credit is redeemable against eligible Elite Business (UK) products and services as set out below. Eligible products and their current pricing are available on request from production@cemg.media and are subject to change. Credit is applied at the price prevailing at the time of redemption.

ELIGIBLE USE OF CREDIT

For brands that are successfully ranked in the EB100 2027, the redeemable credit may be used towards EB100 2027 Awards Ceremony tickets and EB100 profile advertising packages.
